

Sub: - Amended in Rules for Examination G-20.2, G-20.3, G-20.4.

As approved in 37th Examination Committee Meeting was held on 17th December 2012, to implement the procedure for providing photocopies and reassessment of assessed answer books to the students, if demanded by the students under the amended in Rules for Examination G-20.2, G-20.3 & G-20.4 and will be effective from Even 2012 term end examination. The details is as below..

| Sr. No. | Existing Rule | Amended Rule |

| 1. | G-20.2- The verification will be restricted to checking whether all the answers have been examined and that there has been no mistake in the totaling of marks for each question in that theory paper and transferring marks correctly on the first cover page of the answer books mentioned by the candidates are intact. No revaluation of answer book or supplement shall be done. However, valuation be done by same examiner of answer of questions and subquestions remained to be examined on written report from Controller of Examinations to the Principal. Penalty shall be levied to the first examiner for not examining the answers of said questions or subquestions at first attempt. | G-20.2- The verification will be restricted to checking whether all the answers have been assessed and that there has been no mistake in the totaling of marks for each question in that theory paper and transferring marks correctly on the first cover page of the answer books mentioned by the examinee are intact. During verification no reassessment of answer book or supplement shall be done. However, assessment will be done of an answer which has remained unassessed. |
| 2. | G-20.3- The application for verification shall be made by candidate within 7 days from declaration of result. | G-20.3- The separate application for verification and photocopy (including verification) shall be made by examinee in prescribed format within 5 working days from declaration of result. |

| <p>3. G-20.4- No candidate shall claim or be entitled to revaluation or reassessment of his answers or disclosure or inspection of the answer books or other document as these are treated by Govt. Polytechnic Nagpur as confidential.</p> | <p>G-20.4- An examinee who has appeared for latest examination of Government Polytechnic, Nagpur shall be entitled to get a photocopy of his/her assessed answer book/s (AAB) (maximum TWO courses) on due submission of application and payment of fees within the schedule prescribed by Government Polytechnic, Nagpur from time to time in this regard.</p> <p>An examinee who has appeared for latest examination of Government Polytechnic, Nagpur and obtained the photocopy of his/her assessed answer book shall only be entitled for reassessment of his/her assessed answer book/s (AAB) (maximum TWO courses) on submission of application and fees, within the schedule prescribed by Government Polytechnic, Nagpur from time to time in this regard. (An examinee who has not applied for photocopy will not be eligible for reassessment of Assessed Answer Book).</p> <p>The examinee shall not be eligible to apply for the photocopies of the assessed answer books, if any, pertaining to the examinations other than the theory (written) examination such as practical, sessional, Progressive test, project, viva-voce (oral) examinations and also of such examinations of Government Polytechnic, Nagpur where grade is awarded instead of numerical marking.</p> <p>Any delay in supplying the photocopy of Assessed Answer Book and/or of reassessment, owing to reasons beyond the control of the Government Polytechnic, Nagpur, or change of marks consequent to the reassessment of Assessed Answer Book shall not confer any right upon the examinee for admission to the next higher class in the current academic session/year, if the schedule of admission does not permit so.</p> |
